Special Called Council Meeting

The Nauvoo Town Council met for a Special Called Council Meeting on August 8, 2025 at 10:00 a.m. at the Nauvoo Town Hall. Notice of meeting/agenda attached. Mayor Burgett in the chair with clerk Nicole Garner acting as the recording secretary. Mayor Burgett called the meeting to order at 10:00 a.m. The following council members were present upon roll call: Olivia Allbritton, Deborah Barton, Denice Perry, Melinda Wills, and Terry Burgett. Council member Christian Dill was absent. Wills opened the meeting with a prayer and Allbritton led in the Pledge of Allegiance. Keith Sizemore was the only visitor in attendance.

Mayor Burgett explained that this meeting was being held to handle some time sensitive items for the upcoming election. Mayor Burgett then explained that the Poll Inspector for the election had decided not to work the polls. Mayor Burgett introduced Resolution 20250808: A Resolution for the Town of Nauvoo, Alabama Appointing Election Officers. The Resolution would name Denise Hall as the new Inspector; Charlotte Horner as a poll worker; and Peggy Hudson as an alternate poll worker. The resolution further resolved that the above-named officials shall be compensated as follows: \$25.00 each for training; \$125.00 for the Inspector; \$100.00 for each poll clerk. The resolution also allows the town clerk to amend the list of election officers as needed for unforeseen circumstances. Wills moved to adopt and approve Resolution 20250808. Perry seconded the motion and upon roll call vote was as follows: YEAS – Allbritton, Barton, Perry, Wills, Burgett; NAYS – None. Motion carried.

Mayor Burgett presented a contractual agreement between the Walker County Commission and the municipalities of Carbon Hill, Jasper, Sumiton, Dora, Oakman, Parrish, Cordova, and Nauvoo. The agreement would allow the use of the election machines, testing of the machines, the delivery and set up, and return of the machines for the August 26, 2025, election any necessary runoff election on September 23, 2025. The agreement would also allow for the reimbursement from the municipalities to the Commission for the payment made through contracted labor (contractor Marc Stephens) for the above-mentioned work. Each municipality will pay the commission a 1/8 (one-eighth) share of the total amount paid to Mr. Stephens for his services rendered. Barton moved to enter into the agreement with the Walker County Commission and to allow the mayor to sign the agreement on behalf of the Town of Nauvoo. Allbritton seconded the motion and upon roll call vote was as follows: YEAS – Allbritton, Barton, Perry, Wills, Burgett; NAYS – None. Motion carried.

Barton moved to adjourn the meeting with Allbritton seconding the motion. All were in favor and the meeting adjourned at 10.11 am.
